† FX Commission Schedule Terms and Conditions:

† 外匯佣金收費表條款及條件：

1. The FX Commission Schedule will only apply to those accounts designated by the Company as being subject to the FX Commission Schedule in a notice from the Company to the Client. The FX Commission Schedule will not apply to accounts utilising the Company's Dealing Desk model.
外匯佣金收費表只適用於本公司指定的已收到本公司向客戶發出的確認適用此佣金模式通知的賬戶。外匯佣金收費表不適用於使用本公司交易員平台模式的賬戶。
2. Commissions provided above apply to all transactions in rolling spot foreign exchange contracts, per 100,000 lot size. Any lot sizes smaller or greater than 100,000 will be charged on a pro rata basis. Where the calculation of a commission results in a fraction of the smallest denomination of any unit of currency (usually one cent or the like), the Company will round to the nearest whole unit of the smallest denomination of that unit of currency such that (for example purposes only) €0.035 will round to €0.04.

Worked Example:

Client's account has a base currency of EUR. Client buys 90,000 EUR/USD on Wednesday. Client incurs a commission charge of EUR 2.70 at the position's open on Wednesday.

Client's account has a base currency of EUR. Client decides to close 50,000 of its 90,000 position of EUR/USD on Thursday, and the remaining 40,000 of its original 90,000 EUR/USD position on Friday. Client incurs a commission charge of EUR 1.50 on Thursday and a second commission charge of EUR 1.20 on Friday.

The Company may add a markup to the overnight fees it receives from its liquidity providers, which will usually be displayed, in aggregate, on the Company's trading platforms before the position is rolled from one day to the next. The value of the markup may differ between clients, account types and products, amongst other variables. 4. Interest Rate Fee on Negative Balances

We reserve the right to charge accounts with negative balances an interest rate fee of 1.75% above the overnight rate, compounded and charged monthly, of the currency concerned. This fee will apply to negative balances on a monthly basis.

Corporate and Trust Accounts will be subject to a one-time account processing fee of 300 currency units¹ of the currency in which the account is denominated (or 30,000 JPY for JPY denominated accounts) unless you make a minimum initial deposit of 50,000 currency units² or more of the currency in which the account is denominated (or 5,000,000 JPY or more for JPY denominated accounts). Where applicable, the account processing fee will be deducted from the account within five (5) business days after the initial deposit is received by FXCM.³

Monthly Balance Requirement Fee

Corporate and Trust Accounts will be subject to a monthly balance fee of 25 currency units¹ of the currency in which the account is denominated (or 2,500 JPY for JPY denominated accounts) unless you maintain a minimum balance of 50,000 currency units or more in your account of the currency in which the account is denominated (or 5,000,000 JPY or more for JPY denominated accounts). The minimum balance of 50,000 currency units (or 5,000,000 JPY for JPY denominated accounts) must reflect in your account at Trade Rollover (approximately 17:00 EST) on the last day of each month in order to avoid being charged the fee. In cases where you hold multiple accounts with FXCM, the balances will be aggregated and the fee only charged if the combined balance of all accounts is less than 50,000 CCY. Where applicable, the monthly balance fee will be deducted from the account within the first ten (10) business days of the following calendar month.

Initial Funding and Monthly Balance Requirement Fee Notes:

The same logic will apply for each subsequent month that your account balance is below GBP 50,000.00 as of trade rollover (approximately 17:00 EST) on the final calendar day of the month.

6. Inactivity Fee 不動賬戶費

If there are no filled Orders in the trading account for at least one (1) year, you will be subject to a dormant account fee, in return for administrative and information services and/or access provided by FXCM to active accounts. The fee will be equal to the lesser of the remaining balance in your account or 50.00 units of the currency in which your account is denominated (JPY 5,000 for JPY denominated accounts). Account is subjected to a fee on a yearly basis thereafter if the conditions stated above are not met.
