# Stratos Global LLC TRADING VOLUME PROMOTION TERMS AND CONDITIONS

# 条款及条件

## 1. THE PROMOTION

推广活动

The Promotion described hereunder is offered by Stratos Global LLC ("**FXCM**") to new clients of FXCM ("**You**" or "**Your**").

Stratos Global LLC ("福江", "Stratos Global LLC") 向福汇的现有客户以及新客户 ("阁下"或"阁下的") 提供如下文定义的推广活动。

Subject to these terms and conditions, You may be entitled to a Trading volume based bonus up to \$10,000 (the "**Promotion**").

根据此推广活动的条款及条件,阁下可能符合资格获享最高可达 10,000 美金的交易推广活动奖金 ("推广活动")。

#### 2. BINDING AGREEMENT

约束性协议

You agree that by participating in the Promotion, You will be bound by these terms and conditions and FXCM's Terms of Business (including any schedules, annexes, exhibits, amendments and/or side agreements, where any) that apply to Your account and always subject to any applicable laws (together the "**Promotion Terms**"). In the event of any conflicts or inconsistency between FXCM's Terms of Business and these Terms and Conditions, FXCM's Terms of Business shall prevail.

To be eligible to participate in the Promotion You must:

#### 5. PAYMENT OF THE BONUS

5.1 Under this Promotion, You may make multiple deposits to your trading account within a one-month period (starting from the date You place your first deposit into your Qualifying Account) and receive a bonus payment based on the trading volume in your Qualifying Account, as illustrated in the tables below. Under this Promotion, the maximum bonus you can earn in one-month period after placing a deposit into your Qualifying Account is the total dollar amount you deposit within the month, and the bonus amount will not exceed \$10,000USD.

6.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise.

6.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.

#### 一般条款

7.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion and Active Trade Rebate program, but clients must meet the deposit and trading volume requirements respectively.

- 7.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

- 7.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to Your participation in the Promotion. ## 8. GOVERNING LAW AND VENUE

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.
