



Stratos Global LLC DYNAMIC WELCOME PROMOTION TERMS AND CONDITIONS

Stratos Global LLC 迎新推廣活動條款及條件

1. **THE PROMOTION:** The Promotion described hereunder is offered by Stratos Global LLC (“**FXCM**”) to new clients of FXCM (“**You**” or “**Your**”).

推廣活動： Stratos Global LLC (“**福匯**”，“**Stratos Global LLC**”) 向福匯的新客戶 (“**閣下**”或“**閣下的**”) 提供如下文定義的推廣活動。

Subject to these terms and conditions, You may be entitled to a welcome bonus between USD2 and USD650 in accordance with the table listed under Clause 5.1 (the “**Promotion**”).

根據此推廣活動的條款及條件，閣下可能符合資格獲享下方第 5.1 條表格中最高 650 美金的迎新獎金 (“**推廣活動**”)。

2. **BINDING AGREEMENT:** You agree that by participating in the Promotion You will be bound by these terms and conditions and FXCM’s Terms of Business (including any schedules, annexes, exhibits, amendments and/or side agreements, where any) that apply to Your account and always subject to any applicable laws (together the “**Promotion Terms**”). In the event of any conflicts or inconsistency between FXCM’s Terms of Business and these terms and conditions, FXCM’s Terms of Business shall prevail.

約束性協議： 閣下同意，通過參加本推廣活動，閣下將受到此條款及條件和適用於閣下帳戶的福匯業務條款（包括任何附表、附錄、附件、修訂及/或附加協議，如有）所約束，且閣下始終受到適用法律的約束（統稱為“**推廣活動條款**”）。若福匯業務條款與此條款及條件出現任何矛盾或不一致之處，概以福匯業務條款為準。

3. **HOW TO PARTICIPATE:** To be eligible to participate in the Promotion You must:

- d. open a new individual trading account with FXCM on or after 1 July 2024, such account always being subject to FXCM’s Terms of Business, and which must be open and not subject to any dispute or default during the Promotion Period defined below (“**Qualifying Account**”); and

- e. Register online to participate or reply to the Promotion invitation email from FXCM to confirm you would like to join the Promotion.

- f. fund the Qualifying Account with a minimum deposit in accordance with Clause 5.1 (under Clause 5, “**Payment of the Bonus**”)

4. **PROMOTION PERIOD:** This Promotion starts on 12 July 2024 at 08:01 AM (GMT+8) and ends on 30 September 2024 at 23:59 PM (GMT+8) (the “**Promotion Period**”).

5. **PAYMENT OF THE BONUS:**

- 5.1 The Bonus (the “**Bonus**”) will be credited for the initial deposits made into Your live trading Account, ranging from USD100 to USD10,000. The Bonus received will depend on the timing of Your deposit after the activation of Your live trading account, as shown in the table below:

6. LIABILITY: 法律責任

6.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including without limitation interest payments, legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise herein caused by Your participation in the Promotion.

閣下同意，閣下將會根據書面要求在任何時候賠償、捍衛、維護福匯 (包括其董事、高級職員、員工及受讓人)，使其免責於由於或涉及或因閣下作出的任何行為、違責、不作為及/或閣下違反此推廣活動條款所列的陳述和保證附帶引起，包括但不限於由於或涉及與閣下的任何違規行為、不遵從條款、行為或不作為 (不論是疏忽或以其他方式作出)，而導致福匯將會或可能承擔的任何法律責任、罰金、處罰、訴訟、判決、和解、索賠、要求、損失、損害、傷害、賠償、成本與費用 (包括支付利息、客戶與事務律師所定的合理律師費用、其他專業服務費用、墊付款以及調查訴訟費)。

- 6.2 To the extent permitted by law, Your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.

7. GENERAL CONDITIONS: 一般條款

- 7.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but You must meet the deposit and trading volume requirements respectively.
本活動可與【親朋好友推薦計畫】活動同時使用，但客戶必須分別滿足入金和交易量要求。
- 7.2 In the event that FXCM considers Your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from Your Account.
若福匯認為閣下參與此次推廣活動，有違或可能有違此推廣活動條款，福匯保留在不損害本推廣活動條款其他權利的情況下，立即撤銷閣下帳戶參與推廣活動的權利。
- 7.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.
若款項支付有誤，福匯可酌情取消或收回獎金。
- 7.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify You by email.
福匯保留全權酌情更改、修訂、修改、暫停或終止本推廣活動或其任何部份的權利，包括但不限於隨時延長該推廣活動時間而毋須事先作出通知。在此情形下，福匯將盡合理努力以郵件方式通知閣下。
- 7.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to You in connection with the Promotion.
若此推廣活動無法按計劃執行，其原因是福匯不可控因素，包括（但不限於）任何問題或技術故障、或任何適用產品退市或產生重大改變，福匯就此推廣活動對閣下概不負責。
- 7.6 All former and current employees, interns and contractors of FXCM (the “Staff”), and each of its affiliates and subsidiaries and the Staff’s immediate family members and persons with whom such Staff are domiciled are prohibited from participating in the Promotion.
福匯的所有前任雇員以及現任雇員、實習生和承包商（“雇員”），與其所有聯屬公司和附屬公司以及雇員的直系親屬和共同居住人士均不得參與此次推廣活動。
- 7.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
若本推廣活動條款的任何條文被視為無效或無法強制履行，其餘所有條文仍然完全有效。
- 7.8 Unless the context otherwise requires, references to any gender include all genders and use of the singular includes the plural and vice versa.
除上下文另有所指外，凡提及任何性別即包括所有性別，凡使用單數形式即包括複數形式，反之亦然。
- 7.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to Your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.

- 7.10 FXCM may, at its sole discretion, provide You with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in Your possession, the original English version shall prevail.

福匯可以自行酌情決定是否為閣下提供此推廣活動條款的譯本。英文原版是福匯與閣下之間唯一具有法律約束力的版本。如英文原版與閣下持有其他譯文有所出入，概以英文原版為準。

8. GOVERNING LAW AND VENUE: 監管法律及監管地

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.

此等推廣條款將受到聖文森及格瑞那丁法律監管及據此詮釋。雙方不可撤銷地同意，英格蘭及威爾士法院擁有解決任何因此推廣活動條款引起或與之相關的糾紛的獨有管轄權。
