



STRATOS GLOBAL LLC DYNAMIC WELCOME PROMOTION TERMS AND CONDITIONS

1. **THE PROMOTION:** The Promotion described hereunder is offered by Stratos Global LLC (“**FXCM**”) to new clients of FXCM (“**You**” or “**Your**”).

Subject to these terms and conditions, You may be entitled to a welcome bonus between USD2 and USD650 in accordance with the table listed under Clause 5.1 (the “**Promotion**”).

2. **BINDING AGREEMENT:** You agree that by participating in the Promotion You will be bound by these terms and conditions and FXCM’s Terms of Business (including any schedules, annexes, exhibits, amendments and/or side agreements, where any) that apply to Your account and always subject to any applicable laws (together the “**Promotion Terms**”). In the event of any conflicts or inconsistency between FXCM’s Terms of Business and these terms and conditions, FXCM’s Terms of Business shall prevail.

3. **HOW TO PARTICIPATE:** To be eligible to participate in the Promotion You must:

- a. be a natural person;
- b. be over eighteen years of age or over the age of maturity in Your jurisdiction;
- c. be eligible to open an account under Stratos Global LLC ;
- d. open a new individual trading account with FXCM on or after 1 July 2024, such account always being subject to FXCM’s Terms of Business, and which must be open and not subject to any dispute or default during the Promotion Period defined below (“**Qualifying Account**”); and
- e. Register online to participate or reply to the Promotion invitation email from FXCM to confirm you would like to join the Promotion
- f. fund the Qualifying Account with a minimum deposit in accordance with Clause 5.1 (under Clause 5, “**Payment of the Bonus**”)

(collectively, the “**Eligibility Requirements**”).

For the avoidance of doubt, if You do not comply with the Eligibility Requirements, You will not be entitled to participate in this Promotion.

4. **PROMOTION PERIOD:** This Promotion starts on 12 July 2024 at 08:01 AM (GMT+8) and ends on 30 September 2024 at 23:59 PM (GMT+8) (the “**Promotion Period**”).



5. PAYMENT OF THE BONUS:

- 5.1 The Bonus (the “**Bonus**”) will be credited for the initial deposits made into Your Qualifying Account, ranging from USD100 to USD10,000. The Bonus received will depend on the timing of Your deposit after the activation of Your live trading account, as shown in the table below:

* 10 standard lots of FX=1000 contracts of Commodities=3000 contracts of Indices/ssfed XAG/USD and JPN225 are excluded from this promotion.

Please note that the maximum Bonus You can receive is 650 USD, which is 5% of 10,000 USD for the initial deposit and 150 USD for trading volume.

- 5.2 You will only be entitled to one (1) Deposit Bonus payment under this Promotion.
- 5.3 Subject to FXCM’s rights under these Promotion Terms, and provided that You meet the Eligibility Requirements, FXCM shall credit Your Qualifying Account with the Bonus within fourteen (14) business days.
- 5.4 FXCM shall have sole and absolute discretion in determining whether the Promotion can be awarded to You.
- 5.5 You can withdraw the Bonus payment from Your Qualifying Account only after: (i) You have generated a minimum of 2 standard lots in FX or 200 contracts in CFD, excluding JPN225 and XAG and (ii) You have signed up this promotion online or sent an email to promos@fxcmmarkets.com in order to claim the Bonus payment, which has been acknowledged and accepted by FXCM.

6. LIABILITY:

- 6.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including without limitation interest payments, legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise herein caused by Your participation in the Promotion.
- 6.2 To the extent permitted by law, Your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.



7. GENERAL CONDITIONS:

- 7.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but You must meet the deposit and trading volume requirements respectively.
- 7.2 In the event that FXCM considers Your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from Your Account.
- 7.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.
- 7.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify You by email.
- 7.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to You in connection with the Promotion.
- 7.6 All former and current employees, interns and contractors of FXCM (the “Staff”), and each of its affiliates and subsidiaries and the Staff’s immediate family members and persons with whom such Staff are domiciled are prohibited from participating in the Promotion.
- 7.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
- 7.8 Unless the context otherwise requires, references to any gender include all genders and use of the singular includes the plural and vice versa.
- 7.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to Your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.
- 7.10 FXCM may, at its sole discretion, provide You with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in Your possession, the original English version shall prevail.

8. GOVERNING LAW AND VENUE: These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.
