



TRATOS GLOBAL LLC DYNAMIC WELCOME PROMOTION TERMS AND CONDITIONS

Stratos Global LLC 迎新推广活动条款及条件

1. THE PROMOTION 推广活动

The Dynamic Welcome Promotion is offered by Stratos Global LLC (hereafter referred to as “FXCM” or “we”) to new clients of FXCM (“you” or “your”) subject to these terms and conditions and the Terms of Business.

Stratos Global LLC (“福汇”, “Stratos Global LLC”) 向福汇的新客户 (“阁下”或“阁下的”) 提供如下文定义的推广活动。

Open a new CFDs trading account, make an initial deposit within the first week of account activation and earn a bonus credit payment ranging from USD \$10 and USD \$1,000 (the “Promotion”).

开立一个全新的 CFD 交易账户，在账户激活后的第一周内进行第一笔存款以获得机会赢取\$10 美元至 \$1,000 美元的存款奖励 (“推广活动”)。

2. BINDING AGREEMENT 约束性协议

By participating in the Promotion, you agree to be bound by these terms and conditions (the “Promotion Terms”) and FXCM’s Terms of Business which apply to your account. In the event of any conflicts or inconsistency between the Promotion Terms and the Terms of Business, the Terms of Business shall prevail.

阁下同意，通过参加本推广活动，阁下将受到此条款及条件和适用于阁下账户的福汇业务条款（包括任何附表、附录、附件、修订及/或附加协议，如有）所约束，且阁下始终受到适用法律的约束（统称为“推广活动条款”)。若福汇业务条款与此条款及条件出现任何矛盾或不一致之处，概以福汇业务条款为准。

3. HOW TO PARTICIPATE 如何参与

To be eligible to participate in the Promotion, you must:

a. be a natural person;

b. be over eighteen years of age or over the age of maturity in Your jurisdiction;

c. be eligible to open an account under Stratos Global LLC;

- d. open a new individual trading account with FXCM on or after 1 June 2026, such account always being subject to FXCM's Terms of Business, and which must be open and not subject to any dispute or default during the Promotion Period defined below ("Qualifying Account"); and

于 2026 年 6 月 1 日或之后新开设的福汇个人交易账户，此类账户始终受福汇业务条款约束，且必须维持开设，及并无产生任何纠纷或违约事件("合资格账户")；

- e. register online to participate or send an email to promos@fxcmmarkets.com to confirm You would like to join the Promotion;

在线注册参加活动或发送邮件到 promos@fxcmmarkets.com 以确认参加此次推广活动；

- f. fund the Qualifying Account within the first week of Qualifying Account activation in accordance with Clause 5.1 (under Clause 5, "Bonus Calculations");

在推广活动期间，根据第 5.1 条（第 5 条奖金的计算项下）的表格向合资格账户激活后的一周之内进行存款；

- g. be accepted by FXCM to participate in this Promotion;

被福汇接受参加此次推广活动；

(collectively, the "Eligibility Requirements"). (统称为“资格要求”)

For the avoidance of doubt, if you do not comply with the Eligibility Requirements, you will not be entitled to participate in this Promotion.

为避免疑虑，若阁下未能遵从此资格要求，您将无法参与此次推广活动。

4. PROMOTION PERIOD 推广活动期间

This Promotion starts on 1 June 2026 at 00:01 A.M. (GMT+8) and ends on 30 September 2026 at 23:59 PM (GMT +8) (the "Promotion Period").

此推广活动于 2026 年 6 月 1 日凌晨 12 点 01 分开始(GMT+8)，于 2026 年 9 月 30 日晚上 11 点 59 分结束。（「推广活动期间」）

5. BONUS CALCULATIONS 奖金计算

- 5.1 Once you are confirmed as a participant in the Promotion, you may make deposit into your Qualifying Account within the first week of account activation. The amount of any Bonus payable to you will be determined by the amount of your Net Deposit Amount. For the purpose of this Promotion, Net Deposit Amount means total deposits minus total withdrawals made during the applicable time period.



一经确认您可以参加此推广活动，您可以向合格账户激活的一周之内进行首次存款。您可以获取的奖励金额将取决于您存款的金额。在此推广活动中，净存款意思为在时效内的总存款数减去总提款数。

6. PAYMENT OF THE BONUS 奖金的支付

- 6.1 You should sign up for this Promotion online or send an email to promos@fxcmmarkets.com confirming the name and email address and that you meet the Eligibility Requirements under this Promotion.

您需要通过在线填写注册表格或直接发送电子邮件确认您想参与本推广活动，请发送电子邮件至 promo@fxcmmarkets.com。在您的电子邮件中，请说明您的全名、账号并确认您同意本推广活动的条款和条件。

- 6.2 Upon receipt of the online application form or email by FXCM, and confirmation that the Eligibility Requirements have been met, FXCM may, in its sole and absolute discretion, award you a bonus credit payment ranging from USD \$10 and USD \$1,000 (the "Bonus").

在福汇收到您在线注册或者邮箱注册后，并确认您符合资格参加，福汇可以，在拥有全权绝对酌情决定权下，向您提供金额范围为\$10 美金至\$1,000 美金的奖金。

- 6.3 Your Bonus will be calculated one week after activation of your Qualifying Account. Your Total Net Deposit must not be negative at the time the Bonus is calculated. Total Net Deposit means total deposits minus total withdrawals from the date of activation of the Qualifying Account till Bonus calculation date.



您的奖金会在账户激活一周后开始计算。您的总净存款必须在奖金计算时为正数。净存款意思为在合格账户激活至奖金计算期间的总存款数减去总提款数。

6.4 FXCM will credit the Bonus to Your Qualifying Account within 14 (fourteen) business days following the Bonus calculation date.

福汇将在奖金计算后的十四个工作天将奖金存入阁下合格的账户。

6.5 You may withdraw the Bonus payment from Your Qualifying Account only after you have generated a minimum of 20 standard lots in currency pairs or 2000 contracts in CFD, excluding JPN225 and XAG/USD.

您可以从合格账户中提取此奖金，但前提是您完成了至少 2000 合约来回交易量之后，交易产品包括所有货币和差价合约（XAG/USD 和 JPN225 除外）

6.6 You are entitled to receive only 1 (one) Bonus payment under this Promotion.

7. LIABILITY

7.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including without limitation interest payments, legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by you under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise herein caused by your participation in the Promotion.

阁下同意，阁下将会根据书面要求在任何时候赔偿、捍卫、维护福汇（包括其董事、高级职员、员工及受让人），使其免责于由于或涉及或因阁下作出的任何行为、违责、不作为及/或阁下违反此推广活动条款所列的陈述和保证附带引起，包括但不限于由于或涉及与阁下的任何违规行为、不遵从条款、行为或不作为（不论是疏忽或以其他方式作出），而导致福汇将会或可能承担的任何法律责任、罚金、处罚、诉讼、判决、和解、索赔、要求、损失、损害、伤害、赔偿、成本与费用（包括支付利息、客户与事务律师所定的合理律师费用、其他专业服务费用、垫付款以及调查诉讼费）。

7.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and you expressly waive any and all such rights.

8. GENERAL CONDITIONS 一般条款

8.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but you must meet the deposit and trading volume requirements respectively.

本活动可与【亲朋好友推荐计划】活动同时使用，但客户必须分别满足入金和交易量要求。

8.2 In the event that FXCM considers your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from Your Qualifying Account.

若福汇认为阁下参与此次推广活动，有违或可能有违此推广活动条款。福汇保留在不损害本推广活动条款其他权利的情况下，立即撤销阁下账户参与推广活动的权利。

8.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.

若款项支付有误，福汇可酌情取消或收回奖金。

8.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify you by email.

福汇保留全权酌情更改、修订、修改、暂停或终止本推广活动或其任何部份的权利，包括但不限于随时延长该推广活动时间而毋须事先作出通知。在此情形下，福汇将尽合理努力以邮件方式通知阁下。

8.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to you in connection with the Promotion.

若此推广活动无法按计划执行，其原因是福汇不可控因素，包括（但不限于）任何问题或技术故障、或任何适用产品退市或产生重大改变，福汇就此推广活动对阁下概不负责。

8.6 All former and current employees, interns and contractors of FXCM (the "Staff"), and each of its affiliates and subsidiaries and the Staff's immediate family members and persons with whom such Staff are domiciled are prohibited from participating in the Promotion.



福汇的所有前任雇员以及现任雇员、实习生和承包商（“雇员”），与其所有联属公司和附属公司以及雇员的直系亲属和共同居住人士均不得参与此次推广活动。

8.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

若本推广活动条款的任何条文被视为无效或无法强制履行，其余所有条文仍然完全有效。

8.8 Unless the context otherwise requires, references to any gender include all genders and use of the singular includes the plural and vice versa.

除上下文另有所指外，凡提及任何性别即包括所有性别，凡使用单数形式即包括复数形式，反之亦然。

8.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.

阁下须单独承担任何及全部税款，包括但不限于可能适用于阁下参与本次推广活动的联邦税、州税以及地方税。福汇有权利但无义务，根据适用的联邦和地方课税法律、规定、法规、守则或条例作出其认为必要或适宜的扣减和扣缴。

8.10 FXCM may, at its sole discretion, provide you with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in your possession, the original English version shall prevail.

福汇可以自行酌情决定是否为阁下提供此推广活动条款的译本。英文原版是福汇与阁下之间唯一具有法律约束力的版本。如英文原版与阁下持有其他译文有所出入，概以英文原版为准。

9. GOVERNING LAW AND VENUE: 监管法律及监管地

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.

此等推广条款将受到圣文森及格瑞那丁法律监管及据此诠释。双方不可撤销地同意，英格兰及威尔士法院拥有解决任何因此推广活动条款引起或与之相关的纠纷的独有管辖权。
