



STRATOS GLOBAL LLC DYNAMIC WELCOME PROMOTION TERMS AND CONDITIONS

Stratos Global LLC 迎新推廣活動條款及條件

1. THE PROMOTION 推廣活動

The Dynamic Welcome Promotion is offered by Stratos Global LLC (hereafter referred to as “FXCM” or “we”) to new clients of FXCM (“you” or “your”) subject to these terms and conditions and the Terms of Business.

Stratos Global LLC (“福匯”, “Stratos Global LLC”) 向福匯的新客戶 (“閣下”或“閣下的”) 提供如下文定義的推廣活動。

Open a new CFDs trading account, make an initial deposit within the first week of account activation and earn a bonus credit payment ranging from USD \$10 and USD \$1,000 (the “Promotion”).

開立一個全新的 CFD 交易帳戶，在帳戶啟動後的第一周內進行第一筆存款以獲得機會贏取\$10 美元至 \$1,000 美元的存款獎勵 (“推廣活動”)。

2. BINDING AGREEMENT 約束性協定

By participating in the Promotion, you agree to be bound by these terms and conditions (the “Promotion Terms”) and FXCM’s Terms of Business which apply to your account. In the event of any conflicts or inconsistency between the Promotion Terms and the Terms of Business, the Terms of Business shall prevail.

閣下同意，通過參加本推廣活動，閣下將受到此條款及條件和適用於閣下帳戶的福匯業務條款（包括任何附表、附錄、附件、修訂及/或附加協定，如有）所約束，且閣下始終受到適用法律的約束（統稱為“推廣活動條款”)。若福匯業務條款與此條款及條件出現任何矛盾或不一致之處，概以福匯業務條款為準。

3. HOW TO PARTICIPATE 如何參與

To be eligible to participate in the Promotion, you must:

- a. be a natural person;

- b. be over eighteen years of age or over the age of maturity in Your jurisdiction;

- c. be eligible to open an account under Stratos Global LLC;

- d. open a new individual trading account with FXCM on or after 1 June 2026, such account always being subject to FXCM's Terms of Business, and which must be open and not subject to any dispute or default during the Promotion Period defined below ("Qualifying Account"); and

於 2026 年 6 月 1 日或之後新開設的福匯個人交易帳戶，此類帳戶始終受福匯業務條款約束，且必須維持開設，及並無產生任何糾紛或違約事件（“合資格帳戶”）；

- e. register online to participate or send an email to promos@fxcmmarkets.com to confirm You would like to join the Promotion;

在線註冊參加活動或發送郵件到 promos@fxcmmarkets.com 以確認參加此次推廣活動；

- f. fund the Qualifying Account within the first week of Qualifying Account activation in accordance with Clause 5.1 (under Clause 5, "Bonus Calculations");

在推廣活動期間，根據第 5.1 條（第 5 條獎金的計算項下）的表格向合資格賬戶啟動后的一周之內進行存款；

- g. be accepted by FXCM to participate in this Promotion;

被福匯接受參加此次推廣活動；

(collectively, the "Eligibility Requirements"). (統稱為“資格要求”)

For the avoidance of doubt, if you do not comply with the Eligibility Requirements, you will not be entitled to participate in this Promotion.

4. PROMOTION PERIOD 推廣活動期間

This Promotion starts on 1 June 2026 at 00:01 A.M. (GMT+8) and ends on 30 September 2026 at 23:59 PM (GMT +8) (the "Promotion Period").

此推廣活動於 2026 年 6 月 1 日凌晨 12 點 01 分開始 (GMT+8)，於 2026 年 9 月 30 日晚上 11 點 59 分結束。（「推廣活動期間」）

5. BONUS CALCULATIONS 獎金計算

- 5.1 Once you are confirmed as a participant in the Promotion, you may make deposit into your Qualifying Account within the first week of account activation. The amount of any Bonus payable to you will be determined by the amount of your Net Deposit Amount. For the purpose of this Promotion, Net Deposit Amount means total deposits minus total withdrawals made during the applicable time period.

一經確認您可以參加此推廣活動，您可以向合資格賬戶啟動的一周之內進行首次存款。您可以獲取的獎勵金額將取決於您存款的金額。在此推過活動中，淨存款意思為在時效內的總存款數減去總提款數。

6. PAYMENT OF THE BONUS 獎金的支付

6.1 You should sign up for this Promotion online or send an email to promos@fxcmmarkets.com confirming the name and email address and that you meet the Eligibility Requirements under this Promotion.

您需要通過在線填寫註冊表格或直接發送電子郵件確認您想參與本推廣活動，請發送電子郵件至 promo@fxcmmarkets.com。在您的電子郵件中，請說明您的全名、帳號並確認您同意本推廣活動的條款和條件。

6.2 Upon receipt of the online application form or email by FXCM, and confirmation that the Eligibility Requirements have been met, FXCM may, in its sole and absolute discretion, award you a bonus credit payment ranging from USD \$10 and USD \$1,000 (the "Bonus").

在福匯收到您在線註冊或者郵箱註冊后，並確認您符合資格參加，福匯可以，在擁有全權絕對酌情決定權下，向您提供金額範圍為\$10 美金至\$1,000 美金的獎金。

6.3 Your Bonus will be calculated one week after activation of your Qualifying Account. Your Total Net Deposit must not be negative at the time the Bonus is calculated. Total Net Deposit means



total deposits minus total withdrawals from the date of activation of the Qualifying Account till Bonus calculation date.

您的獎金會在賬戶啟動一周后開始計算。您的總淨存款必須在獎金計算時為正數。淨存款意思為在合資格賬戶啟動至獎金計算期間的總存款數減去總提款數。

6.4 FXCM will credit the Bonus to Your Qualifying Account within 14 (fourteen) business days following the Bonus calculation date.

福匯將在獎金計算后的十四個工作天將獎金存入閣下合資格的帳戶。

6.5 You may withdraw the Bonus payment from Your Qualifying Account only after you have generated a minimum of 20 standard lots in currency pairs or 2000 contracts in CFD, excluding JPN225 and XAG/USD.

您可以從合資格帳戶中提取此獎金，但前提是您完成了至少 2000 合約來回交易量之後，交易產品包括所有貨幣和差價合約（XAG/USD 和 JPN225 除外）

6.6 You are entitled to receive only 1 (one) Bonus payment under this Promotion.

7. LIABILITY 法律責任

7.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including without limitation interest payments, legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by you under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise herein caused by your participation in the Promotion.

閣下同意，閣下將會根據書面要求在任何時候賠償、捍衛、維護福匯（包括其董事、高級職員、員工及受讓人），使其免責於由於或涉及或因閣下作出的任何行為、違責、不作為及/或閣下違反此推廣活動條款所列的陳述和保證附帶引起，包括但不限於由於或涉及與閣下的任何違規行為、不遵從條款、行為或不作為（不論是疏忽或以其他方式作出），而導致福匯將會或可能承擔的任何法律責任、罰金、處罰、訴訟、判決、和解、索賠、要求、損失、損害、傷害、賠償、成本與費用（包括支付利息、客戶與事務律師所定的合理律師費用、其他專業服務費用、墊付款以及調查訴訟費）。

7.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and you expressly waive any and all such rights.



在法律許可的範圍下，如因為或涉及本推廣活動而產生糾紛或申索，閣下的訴訟權、對司法或任何其他程式尋求禁制令或任何其他追索權的權利將會謹此被免除，而閣下明確放棄任何及全部此等權利。

8. GENERAL CONDITIONS 一般條款

8.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but you must meet the deposit and trading volume requirements respectively.

本活動可與【親朋好友推薦計劃】活動同時使用，但客戶必須分別滿足入金和交易量要求。

8.2 In the event that FXCM considers your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from Your Qualifying Account.

若福匯認為閣下參與此次推廣活動，有違或可能有違此推廣活動條款。福匯保留在不損害本推廣活動條款其他權利的情況下，立即撤銷閣下帳戶參與推廣活動的權利。

8.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.

若款項支付有誤，福匯可酌情取消或收回獎金。

8.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify you by email.

福匯保留全權酌情更改、修訂、修改、暫停或終止本推廣活動或其任何部份的權利，包括但不限於隨時延長該推廣啟用時間而毋須事先作出通知。在此情形下，福匯將盡合理努力以郵件方式通知閣下。

8.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to you in connection with the Promotion.

若此推廣活動無法按計劃執行，其原因是福匯不可控因素，包括（但不限於）任何問題或技術故障、或任何適用產品退市或產生重大改變，福匯就此推廣活動對閣下概不負責。

8.6 All former and current employees, interns and contractors of FXCM (the "Staff"), and each of its affiliates and subsidiaries and the Staff's immediate family members and persons with whom such Staff are domiciled are prohibited from participating in the Promotion.

福匯的所有前任雇員以及現任雇員、實習生和承包商（“雇員”），與其所有聯屬公司和附屬公司以及雇員的直系親屬和共同居住人士均不得參與此次推廣活動。



8.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

若本推廣活動條款的任何條文被視為無效或無法強制履行，其餘所有條文仍然完全有效。

8.8 Unless the context otherwise requires, references to any gender include all genders and of the singular includes the plural and vice versa.

除上下文另有所指外，凡提及任何性別即包括所有性別，凡使用單數形式即包括複數形式，反之亦然。

8.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.

閣下須單獨承擔任何及全部稅款，包括但不限於可能適用於閣下參與本次推廣活動的聯邦稅、州稅以及地方稅。福匯有權利但無義務，根據適用的聯邦和地方課稅法律、規定、法規、守則或條例作出其認為必要或適宜的扣減和扣繳。

8.10 FXCM may, at its sole discretion, provide you with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in your possession, the original English version shall prevail.

福匯可以自行酌情決定是否為閣下提供此推廣活動條款的譯本。英文原版是福匯與閣下之間唯一具有法律約束力的版本。如英文原版與閣下持有其他譯文有所出入，概以英文原版為準。

9. OVERNING LAW AND VENUE: 監管法律及監管地

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.

此等推廣條款將受到聖文森及格瑞那丁法律監管及據此詮釋。雙方不可撤銷地同意，英格蘭及威爾士法院擁有解決任何因此推廣活動條款引起或與之相關的糾紛的獨有管轄權。
