



**STRATOS GLOBAL LLC DYNAMIC WELCOME PROMOTION
TERMS AND CONDITIONS

1. THE PROMOTION:

The Dynamic Welcome Promotion is offered by Stratos Global LLC (hereafter referred to as FXCM or we) to new clients of FXCM (you or your) subject to these terms and conditions and the Terms of Business.

Open a new CFDs trading account, make an initial deposit within the first week of account activation and earn a bonus credit payment ranging from USD \$10 and USD \$1,000 (the Promotion).

2. BINDING AGREEMENT:

By participating in the Promotion, you agree to be bound by these terms and conditions (the Promotion Terms) and FXCMs Terms of Business which apply to your account. In the event of any conflicts or inconsistency between the Promotion Terms and the Terms of Business, the Terms of Business shall prevail.

3. HOW TO PARTICIPATE:

To be eligible to participate in the Promotion, you must:

- a. be a natural person;
- b. be over eighteen years of age or over the age of maturity in Your jurisdiction;

- g. be accepted by FXCM to participate in this Promotion;



(collectively, the Eligibility Requirements).

For the avoidance of doubt, if you do not comply with the Eligibility Requirements, you will not be entitled to participate in this Promotion.

4. PROMOTION PERIOD:

This Promotion starts on 1 June 2026 at 00:01 A.M. (GMT+8) and ends on 30 September 2026 at 23:59 PM (GMT +8) (the Promotion Period).

BONUS CALCULATIONS

4.1 Once you are confirmed as a participant in the Promotion, you may make deposit into your Qualifying Account within the first week of account activation. The amount of any Bonus payable to you will be determined by the amount of your Net Deposit Amount. For the purpose of this Promotion, Net Deposit Amount means total deposits minus total withdrawals made during the applicable time period.

4.2 The applicable Bonus percentage calculations are outlined in the table below:

5. PAYMENT OF THE BONUS:

5.1 You should sign up for this Promotion online or send an email to promos@fxcmmarkets.com confirming the name and email address and that you meet the Eligibility Requirements under this Promotion.

5.2 Upon receipt of the online application form or email by FXCM, and confirmation that the Eligibility Requirements have been met, FXCM may, in its sole and absolute discretion, award you a bonus credit payment ranging from USD \$10 and USD \$1,000 (the Bonus).



5.3 Your Bonus will be calculated one week after activation of your Qualifying Account. Your Total Net Deposit must not be negative at the time the Bonus is calculated. Total Net Deposit means total deposits minus total withdrawals from the date of activation of the Qualifying Account till Bonus calculation date.

5.4 FXCM will credit the Bonus to Your Qualifying Account within 14 (fourteen) business days following the Bonus calculation date.

5.5 You may withdraw the Bonus payment from Your Qualifying Account only after you have generated a minimum of 20 standard lots in currency pairs or 2000 contracts in CFD, excluding JPN225 and XAG/USD.

5.6 You are entitled to receive only 1 (one) Bonus payment under this Promotion.

6. LIABILITY:

6.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including without limitation interest payments, legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by you under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise herein caused by your participation in the Promotion.

6.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and you expressly waive any and all such rights.

7. GENERAL CONDITIONS:

7.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but you must meet the deposit and trading volume requirements respectively.

7.2 In the event that FXCM considers your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from Your Qualifying Account.

7.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.



- 7.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify you by email.
- 7.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to you in connection with the Promotion.
- 7.6 All former and current employees, interns and contractors of FXCM (the Staff), and each of its affiliates and subsidiaries and the Staffs immediate family members and persons with whom such Staff are domiciled are prohibited from participating in the Promotion.
- 7.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
- 7.8 Unless the context otherwise requires, references to any gender include all genders and use of the singular includes the plural and vice versa.
- 7.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.
- 7.10 FXCM may, at its sole discretion, provide you with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in your possession, the original English version shall prevail.

8. GOVERNING LAW AND VENUE:

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.
