



## STRATOS GLOBAL LLC FXCM HUB PROMOTION TERMS AND CONDITIONS

### STRATOS GLOBAL LLC FXCM Hub 信息 APP 下载奖赏活动 条款及条件

#### 1. THE PROMOTION 推广活动

The Promotion described hereunder is offered by Stratos Global LLC (“FXCM”) to existing and new clients of FXCM (“You” or “Your”).

Stratos Global LLC (“福汇”, “Stratos Global LLC”) 向福汇的现有及新客户 (“阁下”或“阁下的”) 提供如下文定义的推广活动。

Subject to these terms and conditions, You may be entitled to a bonus \$50 under Clause 5.1 (the “Promotion”).

根据此推广活动的条款及条件, 阁下可能符合资格获享下方第 5.1 (“推广活动”)所列出的\$50 美金奖金。

#### 2. BINDING AGREEMENT 约束性协议

You agree that by participating in the Promotion You will be bound by these terms and conditions and FXCM’s Terms of Business (including any schedules, annexes, exhibits, amendments and/or side agreements, where any) that apply to Your account and always subject to any applicable laws (together the “Promotion Terms”). In the event of any conflicts or inconsistency between FXCM’s Terms of Business and these Terms and Conditions, FXCM’s Terms of Business shall prevail.

#### 3. HOW TO PARTICIPATE 如何参与

To be eligible to participate in the Promotion You must:

- (b) be over eighteen years of age or over the age of maturity in Your jurisdiction

- (d) have a valid trading account with FXCM, and which must be live and not subject to any dispute or default during the Promotion Period defined below (“**Qualifying Account**”);

- (e) In order to qualify for the FXCM Hub Promotion bonus eligibility, you must download and install FXCM Hub, send us a screenshot of opening the App’s home page on your phone, and make a new deposit of a minimum of USD 500 into your trading account. You are also required to complete at least 2 lots of trading volume in order to receive the USD 50 bonus. All these need to be completed within the **promotion period**.

- (f) agree and comply with these Promotion Terms.

#### 4. PROMOTION PERIOD 推广活动期间

This Promotion starts on 1<sup>st</sup> June 2026 at 08:01 AM (GMT+8) and ends on 30<sup>th</sup> September 2026 at 23:59 PM (GMT+8) (“**The Promotion Period**”).

#### 5. PAYMENT OF THE BONUS 获取奖金

- 5.1 Under this Promotion, the bonus will be \$50 USD

- 5.2 You will only be entitled to one Bonus payment under this Promotion. You will need to send us the screenshot using the same email address registered with FXCM’s trading account(s).

- 5.3 Subject to FXCM's rights under these Promotion Terms, and provided that You meet the Eligibility Requirements, FXCM shall credit Your Qualifying Account with the Bonus within 14 business days.

受福汇推广活动条款之权利约束，在复核并确认该账户满足资格要求后，福汇将在十四个工作日将奖金存入阁下合格的账户。

- 5.4 FXCM shall have sole and absolute discretion in determining whether the Promotion can be awarded to You.

## 6. LIABILITY 法律责任

- 6.1 You agree to indemnify, defend and hold harmless FXCM (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation and litigation) for or in respect of which FXCM will or may become liable by reason of or related or incidental to any act, default or omission and/or any breach of representation and warranty set forth herein by You under these Promotion Terms including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise.

阁下同意，阁下将会根据书面要求在任何时候赔偿、捍卫、维护福汇（包括其董事、高级职员、员工及受让人），使其免责于由于或涉及或因阁下作出的任何行为、违规、不作为及/或阁下违反此推广活动条款所列的陈述和保证附带引起，包括但不限于由于或涉及与阁下的任何违规行为、不遵从条款、行为或不作为（不论是疏忽或以其他方式作出），而导致福汇将会或可能承担的任何法律责任、罚金、处罚、诉讼、判决、和解、索赔、要求、损失、损害、伤害、赔偿、成本与费用（包括支付利息、客户与事务律师所定的合理律师费用、其他专业服务费用、垫付款以及调查诉讼费）。

- 6.2 To the extent permitted by law, your rights to litigate, to seek injunctive relief or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Promotion are hereby excluded, and You expressly waive any and all such rights.

## 7. GENERAL CONDITIONS 一般条款

- 7.1 This Promotion can be used in conjunction with the Friends & Family Referral Promotion, but clients must meet the deposit and trading volume requirements respectively.

本活动可与【亲朋好友推荐计划】活动同时使用，但客户必须分别满足入金和交易量要求。

- 7.2 In the event that FXCM considers Your participation in this Promotion is, or is likely to be, in breach of these Promotion Terms, FXCM reserves the right, without prejudice to any other rights under the Promotion Terms, to immediately withdraw the Promotion from your Account.



若福汇认为阁下参与此次推广活动，有违或可能有违此推广活动条款。福汇保留在不损害本推广活动条款其他权利的情况下，立即撤销阁下账户参与推广活动的权利。

7.3 FXCM may, in its discretion, cancel, or reverse a Bonus if a payment is made in error.

若款项支付有误，福汇可酌情取消或收回奖金。

7.4 FXCM reserves the right at its sole discretion to alter, amend, modify, suspend or terminate this Promotion, or any aspect of it, including but not limited to extending the Promotion Period at any time and without prior notice. In such event, FXCM will make reasonable efforts to notify You by email.

福汇保留全权酌情更改、修订、修改、暂停或终止本推广活动或其任何部份的权利，包括但不限于随时延长该推广活动时间而毋须事先作出通知。在此情形下，福汇将尽合理努力以邮件方式通知阁下。

7.5 If the Promotion cannot be executed as planned, due to reasons beyond the control of FXCM, including (but not limited to) any problems or technical malfunction, or any applicable instrument being delisted or changed substantially, FXCM shall incur no liability to You in connection with the Promotion.

若此推广活动无法按计划执行，其原因是福汇不可控因素，包括（但不限于）任何问题或技术故障、或任何适用产品退市或产生重大改变，福汇就此推广活动对阁下概不负责。

7.6 All former and current employees, interns and contractors of FXCM (the "Staff"), and each of its affiliates and subsidiaries and the Staff's immediate family members and persons with whom such employees are domiciled are prohibited from participating in the Promotion.

福汇的所有前任雇员以及现任雇员、实习生和承包商（“雇员”），与其所有附属公司和附属公司以及雇员的直系亲属和共同居住人士均不得参与此次推广活动。

7.7 If any provision(s) of the Promotion Terms are held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.

7.8 Unless the context otherwise requires, references to any gender include all genders and use of the singular includes the plural and vice versa.

除上下文另有所指外，凡提及任何性别即包括所有性别，凡使用单数形式即包括复数形式，反之亦然。

7.9 You are solely responsible for the payment of any and all taxes, including but not limited to federal, state and local taxes that may apply to Your participation in the Promotion. FXCM shall have the right, but not the obligation, to make any deductions and withholdings that FXCM deems necessary or desirable under applicable federal, and local tax laws, rules, regulations, codes or ordinances.

7.10 FXCM may, at its sole discretion, provide You with translations of the Promotion Terms. The original English version shall be the only legally binding version for FXCM and You. In case of discrepancies between the original English version and other translations in Your possession, the original English version shall prevail.

福汇可以自行酌情决定是否为阁下提供此推广活动条款的译本。英文原版是福汇与阁下之间唯一具有法律约束力的版本。如英文原版与阁下持有其他译文有所出入，概以英文原版为准。

## **8. GOVERNING LAW AND VENUE 监管法律及监管地**

These Promotion Terms shall be governed by and construed in accordance with the laws of Saint Vincent and the Grenadines. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Promotion Terms.
